DAVID SIMONE - President

David was named President of PolyGram Music Publishing in February, 1994. He received an Honors Law Degree from the University of Leicester. During his career, he held numerous high-level positions, including a that of Chairman of the Board for MCA U.K. as well as Managing Director of Arista U.K. and then Phonogram's U.K. companies. In 1989 he came to America to assume the post of President at UNI Records, based in New York. From there he went on to become senior partner at the Atlanta based law firm of Katz, Smith & Cohen, where he negotiated numerous deals in music, television and film. Immediately prior to joining PolyGram, David was Senior Vicer President, Business Affairs, at Capitol Records. Since accepting his present position at PolyGram, David has been involved in signing such songwriters and artists as Lyle Lovett, Deadeye Dick, Echobelly, and a co-venture deal with SubPop Records.

When discussing the future of PolyGram Music, David Simone notes, "We intend to pursue new opportunities in the acquisition of talent and catalogues and aim to make PolyGram Music Publishing a major player in the U.S. With the advent of the information superhighways and numerous other technological revolutions, there is a great opportunity for music publishing to evolve."

LINDA A. NEWMARK - V.P. Business Affairs

Linda handles the negotiations and drafting of music publishing agreements, oversees acquisitions and promotes the general business development of the company. Before this, Linda was Director of International Acquisitions for PolyGram. Prior to that she worked as a music attorney with the law firm Cooper, Epstein & Hurewitz in Beverly Hills. Linda received her Bachelor of Arts degree in Communications Studies from UCLA and her Juris Doctorate degree from Stanford Law School.

JOAN SCHULMAN - V.P. Administration

Joan has been an executive in music publishing for 20 years. She worked as a Manager of Business Affairs for Dick James Music in New York, a catalogue now owned by PolyGram. After re-locating to Los Angeles, Joan joined Screen Gems/Colgems-EMI, where she became Director of Contract and Copyright Administration. In 1990, she assumed the position of Contract Administration for the PolyGram Music Publishing Gruop in L.A. and in 1993, was promoted to her present position. Joan is responsible for all areas of licensing the songs in the PolyGram catalogue, including uses in films, television and commercials.

RONDA CALL - Creative Director

Ronda is responsible for the acquisition of new bands and writers, arranging collaborations with PolyGram's staffwriters and exploiting the company's extensive catalogue. Since joining PolyGram, Ronda has signed Atlas recording artists, Fig Dish and former Medicine member Ed Ruschay with his new band Maids of Gravity. Both bands will release records this year. Prior to joining PolyGram, she was Creative Manager at EMI Music Publishing. From July 1990 through July 1992, Ronda was Creative Manager at NEM Entertainment.

JOHN BALDI - V.P. of A&R

John has been in music publishing for over 10 years. Prior to his current position, Baldi worked as Creative Director at both BMG Publishing and at Bug Music. At PolyGram John has signed numerous acts, including K.D. Lang, The Meat Puppets, American Music Club, and Gigolo Aunts.

DANNY BENAIR - Senior Director, Film & Television

Danny was a member of the critically acclaimed 80's band, The Three O'Clock, with five albums to their credit. As an avid record collector and movie lover, he enjoys his current position. Danny has been successful in placing PolyGram works in such films as "A Few Good Men," "Sliver," "Benny And Joon," "Dumb And Dumber," "Pulp Fiction," "Boys On The Side," "The Santa Clause," "Higher Learning," and "The River Wild," among others. Danny points out the unique relationship with PolyGram Filmed Entertainment, which has several film companies, including Interscope, Egg, Working Title, Island, and Gramercy.

DAN MARKELL - Creative Manager, Film & Television

Dan is a graduate of the University of Colorado, with a B.A. in Communication/ Industrial Media Management. He has been with PolyGram Music Publishing since March, 1991, and has been in his present position since the fall of 1993. HOLLY GREENE - V.P. and General Manager (East)
